Why not just Self-Represent?

- You will not have the benefit of legal guidance or legal advice. A divorce or custody matter is considered a complex civil case. This is not small claims court. Do not underestimate the importance of this. The judge expects you to understand civil procedure, the art of presenting relevant evidence, and applying the law. Self-representation is essentially the same as diagnosing a medical condition and then performing surgery on yourself without a team of nurses and without having consulted a doctor before your started.
- It will likely cost you more money in the long run. Especially if you are ordered to pay high support payments, or ordered to pay legal fees to the other party's attorney. You could easily forget to assign a debt? Worse, you may lose custody of your children, or end up with a restraining order against you.
- ➤ If the opposing party is represented, or is obtaining legal advice on the side without you knowing, you are at a severe disadvantage from the start. Attorneys are trained to follow procedure, block evidence from being admitted, and they understand exactly what the judge wants to hear. Attorneys also know how to persuade and negotiate a result for their clients.

Can't I just use a Legal Document Assistant (LDA)?

- California authorizes non-lawyers to prepare legal documents for people doing their own legal tasks. These non-lawyer are called Legal Document Assistants. They can only: 1. Prepare the customers' legal documents; and 2. File the customers' legal documents in the appropriate courts
- > LDAs are an ineffective solution at dealing with Family Law matters
- ➤ LDAs cannot provide legal advice, they cannot advocate, they cannot provide any guidance on your case and they cannot represent you. In fact, because they don't analyze your case, they may not even help you prepare the documents correctly.
- Leaves you with a false sense of security, allowing you to believe you have legal guidance and direction, however, LDAs are legally restricted from providing this.
- Self-help centers are simply just another LDA. Don't be fooled.
- Majority of free legal clinics are LDAs.

Unlimited Legal Services for \$30 per month?

- > Several big name services claim to offer unlimited legal consultations, some for as low as \$30 per month. Don't be fooled— you get what you pay for.
- > These services actually farm your matter to local law firms, who then use the "free" consultation to answer a few questions and give you some assurances, then use the remaining time to basically sell you on retaining their services full time. It's nothing more than a marketing scheme to get you as a full time client paying the higher fees.
- > The services will limit you to one call per "issue" or they will not even include family law as part of the offering. That's not very helpful when you need months' worth of continual guidance and advice on your family law matter.
